A message from the Chairman



The 2019-2020 Annual Report is a snapshot of Catholic Homes' performance during a highly challenging year.

It is an honour to help lead this great Catholic organisation as we deliver our Mission founded on the healing ministry of Jesus Christ, to the community of Western Australia.

The key reason Catholic Homes exists is because of this healing ministry of Jesus Christ. We are part of the Church's continuing tradition of providing care, accommodation and social services to older people, many of whom are among the most vulnerable in our community.

Through our heritage of providing exceptional care, we give witness to the belief that every person is unique, every life a sacred gift and every human being a unity of mind, body and spirit.

This year has been unprecedented in terms of the change experienced across the aged care sector. The impact of the COVID-19 pandemic has been astonishing as was the response throughout the community. Catholic Homes moved decisively to keep residents, clients and staff safe and as restrictions ease, our preparedness is ongoing.

We acknowledge our workforce and volunteers who dedicate themselves to enable residents and clients to live quality lives whether it be in their own home, in an independent living or residential care setting.

The Royal Commission into Aged Care Quality and Safety continued its work throughout the year, publishing its interim report in October 2019. The aged care sector awaits the release of the final report by 26 February 2021 and the response by the Commonwealth Government to its recommendations.

The Board and management of Catholic Homes, with the support of our staff and volunteers, continue to build on the solid foundation of our predecessors, to nurture people, develop strong systems and effective infrastructure.



The formation of our people and investment in our systems allows us to continue our mission-focused delivery of Christ-like care to residents and clients

Catholic Homes' financial and operational position remains robust thanks to prudent management and good governance.

Several projects came to fruition this year and our largest project to date, the first stage of the redevelopment of St Vincent's in Guildford, was opened on 28 February 2020 by Bishop Don Sproxton. We will continue our programs of maintenance and renewal to secure the safety, comfort and amenity for staff, residents and their families.

Embedding our gospel values of joy, love and hospitality into our model of care, Care with Purpose, remains one of our key priorities.

Also, strengthening our Catholic identity in our organisational culture and ethos is fundamental to who we are and an expression of our unique ministry of the Church.

In providing this care, we are often in the privileged and sometimes difficult position of affirming life.

What we bring, grounded in our Christian tradition, is belonging, accompaniment, restoration and compassion.

I deeply and sincerely thank our Board Members, Chief Executive, Executive Team and the hundreds of fantastic, dedicated employees and volunteers for their hard work, mercy and devotion as our important task of confirming and celebrating our identity and purpose in a complex world continues.

A message from the Chief Executive



The individuals and teams of Catholic Homes have shined brightly during difficult times.

The reporting year began with the introduction from 1 July 2019 of the national Aged Care Quality Standards regulated by a new agency, the Aged Care Quality and Safety Commission. The Quality Standards are supported by the Charter of Aged Care Rights which also came into effect at that time

Because they promote and protect the independence and rights of people receiving aged care services so that they are treated well, looked after and afforded greater control and choice in their lives, Catholic Homes fully supports the Quality Standards and Charter.

It is very encouraging to know that through our person-centred Care with Purpose model, which has been in place for several years, Catholic Homes was well placed to meet these new arrangements. Our response has comprised a wide ranging review and renewal of our policies and procedures to ensure compliance and that a high level of care is delivered at all times. Staff and management are to be acknowledged for their hard work in these areas.

In line with our commitment to continuous improvement, our efforts to develop our people and systems continued. We invested greatly in a range of new systems to future-proof the organisation.

By doing this we are positioning Catholic Homes as the first choice in aged care as an employer and provider of exceptional care and services.

We celebrated many achievements this reporting year, starting in August when the peak body for aged care and health support services, the Institute of Hospitality in Healthcare, presented its national Brightest Star award to Marist Lodge Chef Parween Ramsahye and a leadership award for Manager Hotel Services Carey Bray.

Our many nominees and finalists in other awards are also to be congratulated for their achievements.

In February 2020 our newest residence, St Vincent's in Guildford, officially opened. The project is highly sympathetic to its history and represents the latest in design and technology, worthy achievements in themselves.

Let's not forget that it is people who give life to and make the residence what it is. All involved are to be commended for their hard work in bringing this new service to fruition, it is a wonderful residence.

In March 2020 with the advent of the COVID-19 pandemic, the Western Australian Government declared a State of Emergency and a Public Health Emergency. In addition to following the directions and advice of State and Federal health authorities, Catholic Homes began to prepare and took a cautious approach in implementing temporary visitation restrictions. The restrictions were ultimately lifted as WA's infection rate diminished. We remain alert and ready to respond should the situation change.

It is worth highlighting everyone's resilience at this time when we successfully moved residents from the old St Vincent's and Marist residences to their new home.

This year we welcomed a number of new staff and celebrated our long-serving employees. Catholic Homes' staff and volunteers are our greatest asset and in welcoming new people, we also pay tribute to those celebrating anniversaries, who are listed later in this report.

The work we are doing to expand our home care offering deserves special mention and the team is congratulated for growing our offering and reputation for quality service.

We look forward to more good news as our services flourish in the Mid West and South West regions.

We are also boosting our residential care services with key Facility Manager appointments at Servite and St Vincent's. Our new managers are led by Donna Kelly in her new role as Executive Manager Residential Care. We welcome and wish our new appointees well in their roles.

It has been an extraordinary year for everyone at Catholic Homes. I extend a heartfelt thanks to our dedicated Board, all staff, volunteers, residents, clients and families for their understanding and support.

May we look back and remember this as a time when we joined together, strengthened by our shared values and in the spirit of love and compassion, served well the Western Australian community.

Mission



The past year has seen some significant challenges in the provision of Pastoral Care services.


Our team explored creative ways to ensure people had access to our services during the COVID-19 period.

- Mass was held and Communion distributed and other responses were maintained using technology and other methods
- At all times appropriate hygiene, physical distancing requirements and risk management strategies were in place
- The dedication of our Pastoral Practitioners meant that people were supported throughout.

A new Board subcommittee was formed in July 2020 to explore Mission and Catholic Identity. It will consider matters including purpose and identity, witnessing and communicating our Catholic history and call to care. Working with the Executive Team, the committee will:

- Develop and engage in a Formation program for the Executive and Board, exploring elements of our Catholic identity and the stories we share
- Review key documents of vision and identity and seeking to articulate Mission more clearly
- · Identifying training and development needs across the organisation, with a view to assisting others to develop and understanding of who we are, why and what we do
- Provide the necessary skills to provide the compassionate and competent care we are called to offer.





Redevelopment and renewal

Our program of asset redevelopment and renewal was maintained with several key projects progressing during the year.

Marist Lodge redevelopment update

Our plans to bring enhanced care and accommodation services in the City of Belmont progressed as the Marist Lodge redevelopment project's Development Application was approved in June 2020.

This paves the way for the detailed design phase, ahead of construction which is planned for mid-2021. Completion of the building is expected in early 2023.

Residents enjoy quality upgrades

We set about improving the amenity and safety at a number of our sites this year including:

- A new nurse call system installed throughout residential care at Castledare
- Home improvements to residents' kitchens at Trinity, with a fresh design and new flooring, appliances, cupboards and countertops installed
- An upgraded fire detection system installed at Trinity
- A new courtyard for residents, families and visitors to enjoy at Archbishop Goody was completed and opened in September.

Futureproofing our operations

A significant investment in new technology is delivering greater flexibility and agility across the organisation.

In a major step forward, we 'went into the cloud' this year. This means information storage, retrieval and other computing systems are served remotely rather than from Catholic Homes' servers.

This is a significant development for the security, flexibility and longevity of our systems and technology. It also enabled key staff to work offsite in early 2020, due to operational requirements.

Other significant projects implemented in 2019-20 include:

- Introduction of new purchasing software, Advanced Requisition Management (ARM), which is replacing our paper based system. ARM gives greater visibility of purchases and better control of expenses
- We upgraded our telecommunications throughout the organisation which has improved connectivity with better internet, communications and data transfer speeds
- Introduction of Solv Injury and Solv Safety software to boost reporting, documentation and management of safety systems
- Major software upgrades to our HR/Payroll system and electronic rostering system, RosterOn were completed and a new superannuation payment software module was installed
- Greater online connectivity was achieved when we provided WiFi technology to all residential care facilities and the rollout of the National Broadband Network took place this year.





Residential Care and Independent Living

To provide the best possible care and accommodation, we have invested greatly in our people, systems and services.

Joy as new service in Guildford opens

We were delighted to welcome our first residents to the revitalised St Vincent's earlier this year, ahead of an official blessing event to mark the opening of the 87-place facility in Guildford.

Designed to capitalise on its stunning riverside location, while retaining the site's heritage values, St Vincent's combines contemporary accommodation and new technology with best practice aged care.

Our first residents moved into St Vincent's in February 2020 and were joined by residents from Marist Lodge in April.

An official launch was held on 28 February 2020 with Perth Auxiliary Bishop Donald Sproxton formally blessing the new building and Wadjuk Noongar Elder Uncle Ben Taylor Cuermara performing a traditional smoking ceremony.

Best practice, training and development

Catholic Homes is creating a sustainable workforce, equipped with the skills and knowledge essential for modern aged care.

We undertook a number of initiatives and introduced new technologies so that our care and clinical services deliver the best possible outcomes and continue to meet Australia's Aged Care Quality Standards.

To ensure ongoing compliance through committee oversight a Quality Committee was established in February 2019 and a Clinical Governance Committee was created in October 2019.

To boost clinical practices and supervision, a Clinical Nurse Manager was appointed to St Vincent's and Castledare.

We improved our clinical policies and procedures with updated information and tools provided to all sites.

We streamlined our medication management processes with the introduction of an electronic medication delivery system for all sites. MedMobile is a quick and efficient system to enable our clinical staff and medication competent carers to electronically sign for medications, and allow our clinicians to gain access to up-to-date medication records from the cloud.

An innovative way to assess our residents' pain has commenced. The PainChek application is used to quickly and confidentially record facial observations on a phone or tablet, enabling clinical staff to monitor the effectiveness of medication and treatments over time.

iCare rollout continues

We continued to implement iCare across all our residences this year. This new electronic system, where staff use mobile devices to gather information for the assessment and tracking of the residents' records, is delivering great results for our residents.

Care with Purpose Pilot Program

During the year, Care with Purpose, the model of care for Catholic Homes, was further embedded throughout the organisation.

A Pilot Program commenced with a range of activities aimed at training and supporting staff:

- An e-learning program was developed using remote video (Zoom) education sessions
- To promote our successes, we published the Care with Purpose newsletter "Out and About"
- · Site audits and a full review were undertaken to evaluate the program's effectiveness.

Swan Lake AT SERVITE


Cooking with Damiano has proven to be a hit with our residents at Servite!

Home and Community Care

To achieve our vision of being the first choice in aged care, our Home Care division continues to put people first with a strong focus on quality.

Despite increasing competition and a downturn in the aged care sector caused by COVID-19, we grew our home care offering to more than 100 Home Care Packages and over 30 Short-Term Restorative Care packages.

Executive Manager Kylie Steele said the attention paid to clients' needs, coupled with a high level of service, meant Catholic Homes' reputation for quality was growing.

Living A FULL LIFE

Diagnosed with epilepsy as a young boy, Ted Warburton leads a full life, especially with the benefit of Home Care.

Ted has the type of epilepsy where he has absence seizures and loses long periods of time. Nonetheless, none of this has stopped Ted from leading a relatively normal life including having a variety of jobs, marrying and having three children, not to mention enjoying his five grandchildren.

Despite additional health complications appearing later in life, since joining the Catholic Homes' Home Care program his lifestyle has improved considerably.

He now has a special bed and armchair, and most significantly a new motorised wheelchair, which Catholic Homes helped him purchase by using some of his package and applying for two grants.

"Home Care has been a great boon and if it weren't for Catholic Homes, we would have never been able to afford the help that we've received," shares Ted. and he enjoys a range of dishes including Cerenia's adobo, a popular Fillipino meat dish.

Food continues to play a big part in Ted's life

As his primary carer, his wife Cerenia has also greatly benefitted from Home Care, particularly after requiring shoulder surgery as a result of pushing Ted's wheelchair for many years. The couple have been married for 34 years and thanks to respite care, Cerenia returned to the Philippines to visit her family, feeling confident that Ted's needs were well taken care of.

Ted remains as active as possible and enjoys spending time with his family and swimming, especially since Catholic Homes organised a membership at a local swimming pool.

"I've always loved Jenny, we've had a lot of fun together and she's practical as well," Mary said.

Judges noted the conservation and repurposing of the heritage buildings enabled them to become an integral part of the revitalised aged care service.


Ocean Star innovation recognised


Notes to the Financial Statement for the year ended 30 June 2020

BASIS OF PREPARATION

The summarised financial statements comprising the Statement of Profit or Loss, Statement of Comprehensive Income, Statement of Financial Position and Statement of Cash flows have been derived from the full financial report for the year ended 30 June 2020 of Catholic Homes Incorporated.

A full description of the accounting policies adopted by Catholic Homes Incorporates is provided in the financial report for the year ended 30 June 2020.

Statement by Members of the Board

Notwithstanding the shortfall in working capital, the Board considers that at the date of this statement there are reasonable grounds to believe that Catholic Homes Incorporated will be able to pay its debts as and when they fall due.

This is because the shortfall of current assets to current liabilities arises due to the requirement to classify resident loans, accommodation bonds and refundable accommodation deposits as current liabilities as the Association does not have an unconditional right to defer settlements for a period greater than twelve months. History suggests that a resident in a retirement village is staying on average for nine years and a resident in an aged care facility for an average of three years.

The Association anticipates that it will repay approximately \$18.5 million of resident loans, accommodation bonds and refundable accommodation deposits in the next twelve months, which will largely be funded by contributions from incoming residents.

The Board declares that the attached financial statements have been derived from the full financial report for the year ended 30 June 2020 of Catholic Homes Incorporated.
