# A Message from the Chairman

With pleasure I present the 2018
Annual Report for Catholic Homes Inc. (CHI),
my first year as Chairman of the Board. It has been
a challenging year, and yet a rewarding one.

We at Catholic Homes continue to focus on our core Values of Christ like Love, Joy and Hospitality. We're committed to ensuring that quality of care is our first priority.

In the last year alone, Catholic Homes has served approximately 800 residents and clients as well as their families across Residential, Home Care and our Independent Living Villas. Our average residential occupancy rate was 97.77%.

To enable us to provide top quality care, we have sought to ensure that our facilities are maintained to a comfortable standard for our existing residents and attractive to prospective new residents. To this end, we completed the \$1.78 million upgrade to Ocean Star Village and commenced

the \$30 million redevelopment to St Vincent's. We're planning continuous improvement projects also across our sites that include upgrades to residential aged care rooms and bathrooms.

We continue to focus on our mission and the delivery of our strategic plan to care for the aged in our community.

From a financial perspective, Catholic Homes achieved a solid performance for the year. We recorded a surplus of \$1.6 million. Our strong balance sheet suggests that Catholic Homes is well placed as we enter into the exciting next phase of our development program.

We have responded to numerous ongoing Government reviews across all aspects of aged care in Australia including Voluntary Assisted Dying and Euthanasia. We'll continue to promote the improvement of End of Life Care outcomes that uphold the sanctity of life.

We face challenges in the coming year as we continue to focus on our mission and the delivery of our strategic plan to care for the aged in our community. Our particular priorities include those with chronic and complex health issues.

This year, we farewelled two long serving Board Members to whom we express our heartfelt appreciation. Peter Messer joined the Board in 2004 and became Board Chairman in October 2015 until his retirement from the Board in October 2017. Peter made a personal and substantial contribution to the Board during a period of significant change in the industry and for Catholic Homes.

Margaret Haydon joined the Board in 2004. Margaret's extraordinary contribution over thirteen years, which included serving as Chair of the Review Committee, was critical to improving organisational governance.

This year we welcomed three new Board members. Fr Vincent Conroy is the nominee of Archbishop Timothy Costelloe SDB.
Paul Andrew and Daniel Lynch joined the Board as well and will bring a great deal of experience and knowledge to the Board.

# A Message from the Chief Executive

The 2017-2018 Financial Year was an exciting and extremely busy year for Catholic Homes.

Three of our facilities, namely Archbishop Goody Hostel, Trinity Village and Servite Village, met all 44 quality objectives and were reaccredited for a further three years by the Australian Aged Care Quality Agency (AACQA). Most pleasing was the positive feedback received by AACQA about Catholic Homes from interviews with residents and families. These outcomes are testament to the hard work of all our staff and their dedication to, and delivery of, quality person-centred aged care.

2017-18 also saw the completion of the first full year of operations of Catholic Homes' Comfort Care Centre, the first of its kind in Western Australia. Designed specifically for those approaching the end of their lives and support for their families, the Centre has been full since opening. Families have been overwhelmed by this service and are extremely grateful for its existence. In a period of increased public debate about Voluntary Assisted Dying and Euthanasia,

the Centre is a powerful demonstration of how terminally ill Western Australians can be cared for.

Responding to the introduction of consumer directed funding in the home care sector early in 2017, Catholic Homes strategically repositioned its Home Care service team. This resulted in increased demand from consumers for Catholic Homes' services including use of the Day Therapy Centre and our Short Term Restorative Care (STRC) programme to full capacity. This has resulted in Catholic Homes applying for additional STRC places in the most recent Aged Care Approvals Round.

Catholic Homes' staff continue to receive national industry recognition for their outstanding care. Castledare's "Date Nights" was awarded the 2017 OSCAR Catering Innovation of the Year Award and the Comfort Care Centre was a finalist in the HESTA Awards for Innovative Care Services. Our facilities at Ocean Star and Castledare

were awarded International Montessori Quality Assured Status.

The year also saw the commencement of construction of the new St Vincent's facility in Guildford. This exciting new 81 bed facility is scheduled to be completed in the 4th quarter of 2019. The start of construction required that we transition a number of services, such as the kitchen and laundry, into the current facility without impacting on ongoing operations. This has posed many challenges particularly in its location next to a construction site and I'm most grateful to all staff involved in ensuring a seamless transition.

We expanded our Registered Nurses and new Facility Managers' Mentoring Programmes, including the development of a Facility Managers' Handbook.

Negotiations for two Enterprise Bargaining Agreements, one for our Registered Nurses and the other for our Carers, Hospitality and Therapy Staff were successfully completed and lodged with the Fair Work Commission.

Major information system upgrades, especially in Human Resources, were implemented and a major review of our Business Information System and Information Technology needs was completed to help plan for future investment.

Safety is paramount to our Care Model and across all our sites. This year saw the introduction of new Fire Warden Training for all staff as well completion of independent, third party electrical, fire and building compliance reviews.

During the year Catholic Homes contributed to a number of Commonwealth Government

reviews into the aged care industry. These included the Legislated Review of Aged Care authored by David Tune and the Review of National Aged Care Quality Regulatory Processes by Kate Carnell and Professor Ron Paterson. Both these reviews made a series of findings and recommendations that have the potential to impact on how aged care services will be delivered in the future.

# Our facilities at Ocean Star and Castledare were awarded International Montessori Quality Assured Status.

An increased emphasis on brand exposure saw active participation at numerous aged care industry shows and expos, and revamped monthly newsletters and the quarterly Dove Magazine. Working closely with key media outlets, we have increased our advertising and editorial content in print, online and on radio.

I wish to acknowledge the performance of the Executive Team and all our wonderful staff who continue to wholeheartedly care and support our residents and clients to enjoy life. Delivered from the heart, their devotion is both humbling and inspiring.

Finally, I wish to thank the Board of Catholic Homes for their ongoing support and for their unswerving commitment to the delivery of the highest quality of aged care to the Catholic Homes community.

# Home Care

# Short Term Restorative Care

Remaining in the comfort of our homes surrounded by our loved ones can improve wellbeing, until the gradual decline of ageing makes living independently difficult.

The benefits of receiving a Home Care service are many, ranging from helping keep families together to alleviating the pressures placed on caregivers. Catholic Homes' Home Care service includes Short Term Restorative Care (STRC) programmes promoting independent living and the delay or avoidance of entering long-term care.

Available in the homes of individuals, in the community or in aged care facilities, or a mix of these depending on the level of care needs, STRC is available for up to eight weeks. Care is delivered by a team of health professionals including your existing doctor to identify and treat any medical conditions.

The types of services available through STRC are extensive and may include physiotherapy, occupational therapy, nutrition advice, emotional support, home maintenance, transport and medical assistance.

There are no citizenship or residency restrictions, and eligibility is determined by an Aged Care Assessment Team.

STRC is ideal for those needing support with everyday tasks, who are motivated to restore their own wellbeing and wish to remain independent and out of long-term ongoing care arrangements for as long as possible. People receiving a Home Care Package are not eligible for this program.

# Additional Home Care services include Day Therapy, which offers a range of services.

This includes podiatry, occupational therapy and physiotherapy. Home Care also provides access to affordable Home Care Packages including Wellness programs, respite care for family members who are caregivers, pastoral care and private services for those requiring a little more support.

# Circle of Men

# **Book Launch**

On 22nd August 2018, the Circle of Men book launch filled the room at Castledare Village.

The book emerged from a facilitated meeting called Circle of Men, where the male residents of Catholic Homes regularly come together in a safe space to engage in conversation and storytelling. Across several facilities, each man is invited to speak freely in turn while the rest of the group listen in confidence and without judgement.

With help from Senior Occupational Therapist Elizabeth Oliver, Circle of Men was introduced to Catholic Homes in 2013 by volunteer Peter Fry, who had witnessed a similar model being successfully run in Queensland. Initially trialled at Archbishop Goody with a small group of men, the project was eventually expanded into other facilities.

The Circle of Men book set out to honour the men and their stories, validate the work of the volunteers involved and to promote Catholic Homes' meaningful work in the aged care sector.

Featuring the heartfelt tales of sixteen of Catholic Homes' male residents, the stories are told in the third person through a series of interviews and edited by volunteer and facilitator Ross Prout.

The book has received positive exposure from the media and the meetings have won Catholic Homes two Better Practice Awards.

Feedback has been equally positive within the Catholic Homes community too, with the families of the men openly expressing their appreciation for the project. Not to mention the way the men's faces lit up when they received their copy of the book at the launch.

# The initiative promotes friendship and learning and helps reduce feelings of isolation while providing enjoyment.

Often moved by the empathy of the men involved, Ross says, "It's a great honour to enable these men to go a little deeper even at this late stage of their journey."

In our understanding of the power of listening and learning from our older community, Catholic Homes has proudly created a lasting legacy.


## **Basis of Preparation**

A full description of the accounting policies adopted by Catholic Homes Incorporated is provided in the financial report for the year ended 30 June 2018.



# Statement by Members of the Board

In the opinion of the Board, the accompanying accounts, as set out on pages 5 to 38\*, are in accordance with the Australian Charities and Not for Profits Commission Act 2012 and present fairly the financial position of Catholic Homes Incorporated as at 30 June 2018 and its performance for the year ended on that date and comply with Australian Accounting Standards and the Australian Charities and Not for Profits Commission Regulation 2013.

Notwithstanding the shortfall in working capital, the Board considers that at the date of this statement there are reasonable grounds to believe that Catholic Homes Incorporated will be able to pay its debts as and when they fall due. This is because, as noted in note 2(c)(x), the shortfall of current assets to current liabilities arises due to the requirement to classify resident loans, accommodation bonds and refundable accommodation deposits as current liabilities as the Association does not have an unconditional right to defer settlements for a period greater than twelve months. History suggests that a resident in a retirement village is staying on average for nine years and a resident in an aged care facility for an average of three years. The Association anticipates that it will repay approximately \$19.0 million of resident loans, accommodation bonds and refundable accommodation deposits in the next twelve months, which will largely be funded by contributions from incoming residents.
